





The School to Prison Pipeline



Alternatives to Suspension

- Suspensions and harsh exclusionary discipline can often worsen or increase the likelihood of youth developing substance use disorders
- Suspension & expulsion are not likely to change the student's behavior
- Suspended student's academic progress is more difficult
- Offers support to youth and their families impacted by substance misuse rather than exclusionary discipline
- Teaches the youth new skills/ coping strategies
- Promotes connection with a peer group that will promote & support substance free activities



Educators change lives by building positive relationships and empowering students to live up to their expectations. Punitive and exclusionary disciplinary consequences work against these efforts, and may accidentally encourage students to "act out" at school. Here are 15 alternatives to suspension that can help students become fluent with important life skills, support positive relationships, and keep students on-track for graduation.







Alternative Peer Groups (APG's)

- APGs in NH
 - Grow youth leadership with youth taking on mentor role as they progress in their recovery
 - APG Facilitators are trained recovery support professionals
 - Youth help choose fun group activities that match their interests
 - Youths' physical and emotional safety and privacy are a priority





Process Used to Define the NH APG Model

Convened Partners

- Reviewed existing literature about Alternative Peer Groups.
- Convened Contributors (youth, families, peer and recovery support providers, SUD treatment providers, state and University partners) to define critical components of the APG.
- Aligned the critical components to SAMSHA's Peer Recovery competencies



School Based Youth Engagement in APG 2021-22 school year










Knowledge Change (n=11)








Cohort 1 Competency Portfolio Data (n=15)





It Takes a Village

- Collaborative effort to help youth & Families engage in therapeutic supports/ two way referral process
- APGs work with Facilitators to understand when a youth/ family may need more intensive supports and refer to a higher a higher level of care
- APGs set norms with youth and encourage youth to hold each other accountable, as well as establish appropriate boundaries
- Youth & Family supports are a critical component of the continuum of care in behavioral health and enhance Therapeutic Services










