

Leadership Education in Neurodevelopmental and Related Disabilities (LEND) Trainee Application 2024-2025

Applications are accepted beginning in December each year. Complete application packets will be reviewed by our team. Interviews will be scheduled with eligible applicants beginning in late January. This process will continue until all spaces have been filled.

Applications are accepted from:

- 1. **Graduate students** in early childhood special education, human development & family studies, nursing, nutrition, occupational therapy, pediatrics, physical therapy, psychology, public health, social work, speech language pathology, or other related disciplines. **Applicants must have earned a minimum of a bachelor's degree**.
- 2. Professionals working in the community supporting children and youth (birth to 21 years) with neurodevelopmental disabilities and/or special health care needs and their families (i.e., early support and service providers, school administrators, general & special educators, related service professionals, and health care providers). Applicants must have earned a minimum of a bachelor's degree.
- Advocates with a disability or family members of a person with a disability and/or complex health care needs. Applicants with demonstrated leadership experience are welcome to apply.

A requirement of the program includes a commitment of at least **300 hours** over a 9-month period. Trainees who are accepted into the program will receive a stipend provided by the Maternal and Child Health Bureau.
